The role

New funding means that we have a vacancy for a full-time specialist employment caseworker in the active and experienced team at Derbyshire Law Centre. We are looking for someone who can start immediately and the post will be for a fixed-term period until the end of June 2021.

Applicants should be experienced with all aspects of employment law, including discrimination. They will have run their own caseload and be familiar with negotiating settlements out of court, and advocacy in the Employment Tribunal. Experience of working in, or leading on project work would be advantageous.

The postholder will be a member of the Collective Management Team and undertake shared duties in the overall management of the Law Centre.
